That at a meeting of the aforesaid organization held pursuant to the by-laws or

regulations of the said organization, they were authorized and directed to apply for incorporation. That the said organization holds, or desires to hold, property in common for a Religious, Educational, Social, Fraternal, Charitable or other elecmosynary purpose, or any two or more of said purposes, and is not organized for the purpose of profit or gain to the members, otherwise than is above stated, or for the insurance of life, health, accident or property-and that three days' notice in the dreenville Daily Herald, a newspaper published in the County of Greenville, has been given that the aforesaid Declaration would be filed.

And Whereas, The said Doclarants and Petitioners further declared and affirmed:
