Also all that certain lot, piece or parcel of land situate, lying and being in the State and County aforesaid in Glassy Mountain Township on Fall Creek, containing one hundred (100) acres, more or less, beginning on a chestnut 3xom thence nearly North west a straight line to a Hickory 3xom, thence nearly West to a Rock 3xom near Jas. Gosnell's old House, thence about South with Chas. Gosnells line to a Pine 3xom, thence with Harris Pittmans line about East to a Hickory, thence nearly South-east to the beginning;
