Co. Situated and contained within the following meets & bounds: -Beginning at an iron pin on Hammett St. thence N. 68 3/4 W. One hundred feet along said Hammott St. to iron pin thence 21 1/4 E. Two hundred and fifty feet to iron pin thence S. 68 3/4 E. One hundred feet to iron pin thence N. 21 1/4 W. Two hundred and fifty feet to beginning corner on Hammott St. Containing 25000 Square feet more or less Bounded by lands of F.W.Mfg. Co. C.G. Morrell and Hammett St.
