have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said  
M.W. Speights and W.A. Gilreath all that piece parcel or lot of land lying and being in  
the City & County of Greenville State of South Carolina, fronting 38 feet on Anne Street  
and running back on one side 97 feet and about 96 feet on the other side, said lot begin-  
ning at a point on Anne St. 108 feet from corner of Anne & Vulcan Streets, thence N. 12° 30'  
W. 96' feet to stake, thence S. 77° 30' W. 38 feet to stake in rear of Thos. Briar's house;  
thence S. 12° 30' E. 97' feet to Anne Street & thence with Anne St. 38 feet to beginning cor-  
ner. This being one half of lot conveyed to J.P. Oeland by C.H. Crook and being a part  
of lot # 9 of land formerly belonging to Mrs. Crook. Being lot conveyed to Rebecca A. Howe
