L. Paul's lot thence along line of Head's S. 9° 45' W. 65 ft. to said corner thence along line of Head's S. 9° 45' E. 2.37 to stone corner of Head's lot, thence S. 9° 45' W. 2.38 to granite on Armstrong's line thence with Armstrong S. 11° 26' E. 12.73 to a stone, thence S. 88° 48' W. 960 to corner on Gary line thence S. 45' W. 13.95 to a stone, thence S. 76° 15' E. to stone in center of Georgia Road, thence along Georgia Road to beginning corner continuing fifteen and one quarter acres (15.25) more or less.
