Dean) for the City and County of Greenville, in the State aforesaid, in consideration of the sum of One Hundred and Fifty Dollars, in hand paid at and before the sealing of these presents by John Henry Charles, of the City and County of Greenville, State aforesaid (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said John Henry Charles all that his parcel of land situated in the rear of the lot conveyed by Bessie R. Stelle to John Henry Charles, said lot being situated on South 8th Street Washington Avenue, at the corner of the city of Greenville, in said lot being a part of the property owned by W. J. N. Dean and F. W. S. Dean, being a tract of land containing 160 feet long 160 feet wide, and having the following lines and corners, to wit: Beginning at a point on the south side of the lot above described, running due North 160 feet to the rear line of the property of W. J. N. Dean and F. W. S. Dean; thence North 82° 15' East 160 feet to the rear line of the property of W. J. N. Dean and F. W. S. Dean; thence due East 160 feet to the rear line of the property of W. J. N. Dean and F. W. S. Dean; thence due South 82° 15' West 160 feet more or less to an open space, being the southwest corner of lot 710 #4 referred to above; thence with rear line of lot 710 #4 160 feet to the beginning corner of W. Heirs and Assigns, against ourselves and our Heirs, and against every person whomsoever lawfully claiming or to claim the same or any part thereof.
