KNOW ALL MEN BY THESE PRESENTS, That David Burns of Greenville

in the State aforesaid, for and in consideration of the sum of Twenty-two hundred and thirty Dollars, to me in hand paid at and before the sealing of these presents by M. H. Irvine

(the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said M. H. Irvine all that piece, parcel, and tract of land, situate, lying and being in Greenville Township, in the County of Greenville, and in the State aforesaid, a little beyond the northern limit of the said city of Greenville, on the waters of Redland Creek, and adjoining lands formerly owned by Mrs. Rachel Mark, land of E. W. Nordwood, Lewis H. Cole and others and containing fully two (2) acres, more or less. This is the same land that was to me sold and conveyed by Custace Pollock by deed bearing date November 2, 1903, and duly recorded in the office of the Register of Meuse Conveyance for the County and State aforesaid, in book S. C. at page 46, and was to the said Custace Pollock conveyed by Jefferson S. Walker, by deed dated November 10, 1885, duly recorded in book R. R. at page 184. The description of the said deed is hereby adopted, and made part of this instrument of conveyance. By metes and bounds, course and distance the land may be more accurately described, as follows: Beginning at a bend in the street on a stake 3X N. thence N. 50 E. 18.40 to a stake 3X N. New bridge thence N. 88 1/2 E. 3.50 to a stone 3X N. thence N. 52 1/2 E. 15.38 to a stake 6X N. by a beach 3X N. thence N. 87 1/2 E. 4.12 to a White Oak 3X N. thence S. 80 1/4 E. 2.18 to a stone 3X N. thence N. 40 1/2 E. 5 to a White Oak 3X N. thence N. 76 1/2 E. 3.17 to a stone (formerly a White Oak) 3X N. thence S. 4 E. 15.50 to a stone 3X N. thence S. 68 1/2 E. 16.50 to the beginning.

TOGETHER with all and singular the Rights, Members, Hereditments and Appurtenances to the said Premises belonging, or in anywise incident or appertaining.

TO HAVE AND TO HOLD, all and singular the said premises before mentioned, unto the said M. H. Irvine and to his Heirs and Assigns forever.

And I do hereby bind myself, my Heirs, Executors and Administrators to warrant and forever defend all and singular, the said premises unto the said M. H. Irvine and to his

Heirs and Assigns, against me and my Heirs, and against every person whomsoever lawfully claiming or to claim the same or any part thereof.
