(the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said Decatur Howard all that piece of land or tract of land situate lying and being in the County of Greenville state aforesaid containing fifty (50) more or less, on the branch waters of South Saluda river, and is part of tract known as the Jeff Darton land, having following metes and bounds, beginning on the Shaded Hickory 3x thence in south direction to a maple 3x thence in a west direction to an oak 3x, thence in a Northwest direction to a stone 3x on Peter Lindsey's line, thence in a north direction to a chestnut 3x on Thos Lindsey's line, thence in a south direction to a chestnut 3x on Thos Lindsey's line, thence in an easterly direction to the beginning corner bounded by lands now or formerly belonging to Thos Lindsey, Peter Lindsey and others, being same tract conveyed to us by Jas. Lindsey Jr. one hundred acres and the other 5d acres having been conveyed to Col R. E. Johnston.

TOGETHER with all and singular the Rights, Members, Hereditaments and Appurtenances to the said Premises belonging, or in anywise incident or appertaining. TO HAVE AND TO HOLD, all and singular the said premises before mentioned, unto the said Decatur Howard and his Heirs and Assigns forever.

And we do hereby bind ourselves and our Heirs, Executors and Administrators to warrant and forever defend all and singular, the said premises unto the said Decatur Howard and his

Heirs and Assigns, against us and our Heirs, and against every person whomsoever lawfully claiming or to claim the same or any part thereof.
