(the receipt whereof is hereby acknowledged) have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said E. J. Griffis all that piece, parcel and tract of land situate, lying and being in the County of Greenville and State aforesaid, on the Spartanburg road, and having the following lines, metes and bounds, to wit: beginning at a stone 3x on the Spartanburg road; N. F. Burgess corner, and running thence with said road S. 53° 27' 15" to a bend of the road, thence still with the road, S. 74° 11' 89" to a stake, thence along the road S. 75° 21' 3.04 to a stone on the road, thence still with the road S. 74° 26.60 to a persimmon thence S. 25° E. 17.00 to a stake 3x, thence S. 44° 27' 9.58 to a stake 3x, thence S. 47° E. 19.00 to a stake, thence N. 46° E. 2.65 to a stone 3x, thence N. 50° E. 3.16 to a poplar 3x, thence N. 78° E. 1.28 to a red oak 3x, thence N. 23° W. 8.30 to a red oak 3x and thence N. 35° W. 13.50 to the beginning corner, being the tract of land conveyed to me by Peter Nelson, as administrator of the estate of Christine Nelson, and conveyed to the said Christine Nelson by A. S. Duncan.
