and lot of land situate, lying and being in the City and County of Greenville in the State aforesaid, on Washington street, and having the following lines, metes and bounds of foot, beginning on an iron pin on the North side of Washington street Goodlett's corner and running thence along the North side of Washington street, S. 65 E., 58 $\frac{1}{2}$ feet to an iron pin in the North line of said street, Mrs. Mary Harrison's corner, thence, with Mrs. Harrison's line N. 24 E. 92 feet to an iron pin Mrs. Harrison's and W.A. Hunning's corner, thence with W.A. Hunning's line N. 70 W. 58 $\frac{1}{2}$ feet to an iron pin in said Hunning's and Goodlett's corner, thence with Goodlett's line S. 26 W. 87 feet to the point of beginning.
