(the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said John M. Anderson all that piece, parcel or tract of land situate lying and being in Greenville County and State aforesaid on White Horse Broad known as a part of the French Land, having the following metes and bounds to wit: beginning on a stake thence N 80° E 18.05 to stake, thence N 40° E 13.00 to a stone; thence N 34° W 8.90 to an iron pin; thence S 77° E 5.34 to iron pin; thence S 22° W 22.00 to beginning corner bounded by lands of Sarah Fuller, H. M. Myers & Dr. R. D. Smith #5 and #4 of a sub-survey containing twenty seven (27) acres more or less,

TOGETHER with all and singular the Rights, Members, Hereditaments and Appurtenances to the said Premises belonging, or in anywise incident or appertaining. TO HAVE AND TO HOLD, all and singular the said premises before mentioned, unto the said John M. Anderson his Heirs and Assigns forever.

And I do hereby bind myself my self John M. Anderson his Heirs, Executors and Administrators to warrant and forever defend all and singular, the said premises unto the said

Heirs and Assigns, against all and every person whomsoever lawfully claiming or to claim the same or any part thereof.
