 (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said L. O. Patterson, and unto his heirs and assigns forever,

All that certain piece, parcel or tract of land situate, lying and being in the County of Greenville, State of South Carolina, a short distance south east of the Corporate Limits of the City of Greenville, having the following dimensions and boundaries, according to a plat thereof prepared by J. A. Southern, bearing date April 21, 1893, to wit, Beginning at a Stake on the South side of the Augusta Road, 5 A.M. which stake is 96 links from Stake 3x0m. in ditch on corner of land of O. R. Hartley and running thence S. 37° W. along line of Mrs. A. M. Covington's land, 1.276 chains to a stone or iron pin 3x1.5m. thence S. 37° W. along Mrs. Dowd's line 1.580 chains to a stone or iron pin 3x1.5m. thence S. 46° W. 9.58 chains along line of R. H. Darles land, to a stone or iron pin 3x1.5m. in corner of tract No. 3. thence S. 36° E. 32.60 chains along line of said tract No. 2 still owned by me, to an iron pin 3x1.5m. on the Augusta Road thence S. 46° E. 4.638 chains along the south side of the Augusta Road 4.77 chains to the beginning corner containing Nineteen and one half 1/4 acres more or less and known as Tract No. 3 on said plat of the lands of the late James Birnie. This being the same tract of land purposed by Caroline H. Birnie, James Birnie and Mary S. Lewis, my self & husband Birnie, by deed bearing date January 18, 1895, and recorded in the office of the Register of Deeds Conveyance for Greenville County, South Carolina, on January 21, 1895, in said Book "B.B.B." at page 189 and by the said James Birnie purposed to me, under the name of Mary S. Lewis, by deed bearing date May 31, 1898, and recorded in said office on June 8, 1898, in said Book "F.F." at page 40.

TOGETHER with all and singular the Rights, Members, Hereditaments and Appurtenances to the said Premises belonging, or in anywise incident or appertaining. TO HAVE AND TO HOLD, all and singular the said premises before mentioned, unto the said L. O. Patterson and his Heirs and Assigns forever.

And I do hereby bind myself and my Heirs, Executors and Administrators to warrant and forever defend all and singular, the said premises unto the said L. O. Patterson.

And I do hereby bind myself and my Heirs, and against every person whomsoever lawfully claiming or to claim the same or any part thereof.
