All my right title and interest in a certain parcel or lot of land situated on Buchner st and in the 1st Ward of the City of Greenville and has the following metes & bounds: Beginning at a stake on the west side of Buchner st and 68ft south of the south side of a 16th alley and running thence with Buchner st S. 47° W. 48 ft to a stake in the line of a lot bought by Matilda Walker trustee on the 15th day of October 1881 and thence N. 87° W. 145 1/2 ft to a stake; thence N 7° E. 68 ft to a stake on the back line; thence S. 78° E to a stake on Buchner st; the beginning point of this being the Southern eye half of a lot purchased by our mother Matilda Walker from M. L. Marchant Oct 23rd 1882; and held in trust for your selves and to Doffney Walker.

TOGETHER with all and singular the Rights, Members, Hereditaments and Appurtenances to the said Premises belonging, or in anywise incident or appertaining TO HAVE AND TO HOLD, all and singular the said premises before mentioned, unto the said Carrie May Thomas her Heirs and Assigns forever.

And I do hereby bind myself my Heirs, Executors and Administrators to warrant and forever defend all and singular the said premises unto the said Carrie May Thomas her Heirs and Assigns, against myself and Heirs, and against every person whomsoever lawfully claiming or to claim the same or any part thereof.
