 beginning at any iron post by David street, just beyond
 the incorporate limits of the City of Greenville and east of
 the Southern railway track and running thence $\frac{1}{2}^{\text{nd}}$ N. $48^{\circ} 30'$ E. ninety-five feet
 to a stake: thence $\frac{1}{2}^{\text{nd}}$ N. $48^{\circ} 30'$ E. ninety-five feet to a stake by
 David street: thence with David street $\frac{1}{2}^{\text{nd}}$ N. $48^{\circ} 30'$ E. ninety-five
 feet to the beginning corner being the northern portion of
 lot #73, of tract # of the Haquinet lands, according to a
 plat made by Wm H. Lee Surveyor, being a part of the
 land conveyed to me by James L. Orr, Executor.
