of Greenville in the County of Greenville and  
in the State aforesaid, for and in consideration of the sum of Three Thousand (\$3,000.00)

Dollars, to and in hand paid at and before the sealing of these presents by

Lillian L. McBrorey of the same place(the receipt whereof is hereby acknowledged) have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said Lillian L. McBrorey all that certain piece, parcel or

lot of land situate, lying and being in ward one, of said City of Greenville, County and State aforesaid, fronting 61 feet on Laurens street and known as lot #9, on plan by J. R. Landreth, surveyor, recorded in R. M. L. office for said County, in volume D. D. I. Jr., beginning at any iron pin at the corner of lots #9 + #10, being 171.75 feet from north street, and running back from said Laurens street, one hundred and six (66) feet to lot #2, on said plan, (along line of lot #10); corner of #9, #10 + #1; thence along line of lot #2, sixty one feet to corner lot #8, iron pin; thence along line of #8, one hundred and six and  $\frac{7}{8}$  feet, to all iron pin on said Laurens street; thence along said street, sixty one (61) feet, to the beginning corner, and being the same lot on which is my present residence, and was to me conveyed by Thomas T. Earle, by deed bearing date December 16<sup>th</sup>, 1901, and recorded in R. M. L. office for said County in volume D. D. I. Jr., page 387, the said Thomas T. Earle reserving to himself his heirs and assigns, the right to keep, maintain and use a sewer through said lot, and beneath the surface thereof, where a sewer there ran through same, connected with building on lot #2, known as the Greenville Sanitarium and running onto said Laurens street.
