
KNOW ALL MEN BY THESE PRESENTS, That Stone Land Company a corporation in the State aforesaid, for and in consideration of the sum of One thousand Dollars, to it in hand paid at and before the sealing of these presents by Lena W. Stone (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said Lena W. Stone, all that piece, parcel and lot of land in the City of Greenville, County of Greenville, and State of South Carolina on the north side of Stone Avenue, beginning at a point on Stone Avenue three hundred and twenty-six feet, more or less, from the corner of Robinson street, being the south-east corner of what is known as the Carson Lot, and running thence in a northerly direction two hundred feet in a line paralleled with Robinson and Wilton streets to corner of lot owned by Mountain City Land and Improvement Company and lot of D. P. Kiddis; thence easterly one hundred and eight feet eight inches, more or less, paralleled with Stone Avenue with Willis line, to corner of lot of Avery Patton thence southerly two hundred feet paralleled with Wilton and Robinson streets to corner of Stone Avenue two hundred and seventeen feet four inches, from the corner of Wilton street; thence westerly with Stone Avenue one hundred and eight feet eight inches to the beginning corner. This is now known as the "Dillard Lot."

TOGETHER with all and singular the Rights, Members, Hereditaments and Appurtenances to the said Premises belonging, or in anywise incident or appertaining. TO HAVE AND TO HOLD, all and singular the said premises before mentioned, unto the said Lena W. Stone, her Heirs and Assigns forever.

And it do hereby bind itself and its Successors, Heirs, Executors and Administrators to warrant and forever defend all and singular, the said premises unto the said Lena W. Stone, her Heirs and Assigns, against itself and its Successors, Heirs, and against every person whomsoever lawfully claiming or to claim the same or any part thereof.


