NOW KNOW ALL MEN BY THESE PRESENTS, That I, Mrs Georgia A. Thackston, Widow of late James F. Thackston, who died on February 24th 1907, to whom I was married to him, the said James F. Thackston, on December 23, 1905, in consideration of Five hundred and seventy-five (\$575.00) Dollars to me in hand paid, at and before the sealing of these presents and further consideration that I am to reside on, and receive all rents issues and proffits, of the 140 acre tract of land now owned by W.K. Thackston under said deed of December 16th 1905, (Vol "RRR" 236), for the year 1907, and no longer estimated to be worth \$160.00 also in consideration of two horses one bay named "Billy" at \$125.00, one bay named "George" at \$50.00, all corn now on said place, at \$50.00, one buggy, single and double harness, shafts and buggy pole, at 40.00 all provender at \$20.00, all Cowpeas at \$5.00, meat on hand at \$10.00, wheat on hand at \$5.00, and two horse wagon and harness, at \$35.00, one jersey Cow with horns, at \$25.00 all now on said place, I do hereby forever release and relinquish in full unto said W.K. Thackston all claim, demand, right, or equity, to a support and maintenance as provided in said deed or otherwise, this gross sum being in final and full satisfaction of any annual or periodical claim or right to support by said W.K. Thackston, his grantees, heirs or assigns, in law or equity, now and forever,

And I do hereby bind me and my heirs and assigns to forever warrant and defend said claim in full satisfaction unto said W.K. Thackston his heirs and assigns forever.
