All that certain lot of land, situate on Main Street, in the City of Greenville County and State aforesaid, beginning at corner of Government lot, running; thence with Main Street Twenty-one feet; thence running back at right angle with Main Street, and parallel with line of Government lot Sixty-two and one -half feet; thence South twenty-one feet to line Government lot; thence with line of Government lot Sixty-two and one-half feet to the beginning corner, containing thirteen hundred and thirteen and one-half square feet more or less.
