Freeman (formerly S.C. Clyde) and the Railroad Lot, extending Northward to Rhett Street and containing one-half acre more or less, being the same lot conveyed to H.W. Cely guardian (for T. Lake Cely) by C.A. Cook on the 17th, day of April 1890 and to the said C.A., Cook by M.C. Carpenter on the 30th, day of March 1889.

Together with all and singular the rights, members, heraditaments and appurtenances to the said premises belonging or in anywise incident or apportaining. To Have and To Hold all and singular the said premises before mentioned unto the said Emma A. Cowsert, her heirs and assigns forever. And I H.W. Celey so far as being late Guardian as aforesaid do hereby bind myself as such and I the said T. Lake Cely do herby bind myself my heirs, executors, administrators to warrant and forever defend all and singular the said premises unto the said Emma A. Cowsert, her heirs and assigns against me the said H.W. Cely as late Guardian as aforesaid, and against me and the said T. Lake Cely and my heirs, and against every person whomscever lawfully claiming or to claim the same or any part thereof.
