"Owing to present conditions in our Conference, we recommend that the Rock Falls Industrial School Farm be sold to J.H.Merritt at its original cost, and that the Conference Committee confer with the donors and make such adjustment with all interested individuals as becomes necessary in winding up the business of the Enterprise".

Constitution of the South Carolina Conference of Seventh Day Adventists-Article 4- Officers and their duties.

Section 2- The duties of officers shall be such as usually pertain to these offices.

Section 3- Duties of the Executive Committee: It shall be the duty of the Executive Committee to appoint, thru one of our weekly papers, the time and place to hold the annual conference and to call special conference whenever in their judgment it may be needful to do so; to take general supervision of all labor performed in and for the conference; to exercise general watch care over all matters pertaining to the interests of the cause within the bounds of this conference; and to fulfill all vacancies in the offices of the conference.
