Norwood of the City and County of GReenville, in the State aforesaid, in consideration of the sum of Twenty nine dollars to me in hand paid at and before the sealing and delivery of these presents by Phoebe W. Fuller (the receipt whereof is hereby acknowledged) have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said Phoebe W. Fuller all that certain lot, piece or parcel of land known and designated as the west half of Lot numbered one hundred and two (102) on the municipal plat of Springwood Cemetery, in the City and County of Greenville and State of South Carolina, having the following metes and bounds, to wit: - Beginning at a stake in the middle of the north line of said lot No.102 and nine (9) feet from the public walk on which said lot fronts or faces; and running thence southwardly through the middle of said lot about thirteen and one half (13-2) feet, in a curved line parallel with said public walk, and at all points nine (9) feet distant therefrom, to a stake in the middle of the south line of said lot, and nine (9) feet from side walk; thence westwardly in a straight line nine (9) feet along line of Lot No.103 to a stake which is the common corner of lots numbered 66, 67,102 and 103; thence northwardly twelve (12) feet in a curved line separating lots 66 and 102, which line is parallel with said public walk, and at all points eighteen (18) feet distant therefrom, to a stake, which is the common corner of lots numbered 65,66,101 and 102; thence eastwardly in a straight line nine (9) feet along line of Let No.101 to the beginning corner; this being that portion of Lot No 102 which includes the grave of Miss H.F.
