WHEREAS, Apalacha Mills, a corporation created under the laws of the State of South Carolina did heretofore construct a dam across South Tyger River at the Shoals near its Mill Building which causes the water of said river and tributaries to back. And whereas it is claimed by the Grantors herein that the opertaion of said Dam has injured, and will continue to injure the lands here inafter described. And whereas, a settlement has been reached between said Apalache Mills and the Grantors herein.

NOW. Therefore, We, Jesse R. Rector and William E. Rector, individually, and as Executors of the last will and testament of Nathaniel Greene Rector, which has been duly admitted to Probate in the Probete Court for Greenville County, and Martha A. Hudson, for and in consideration of the sum of Four hundred dollars (\$400.00) to us in hand paid, the receipt whereof is hereby acknowledged, have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said Apdache Mills, its successors and assigns, the right, so far as the lands hereinafter described are concerned, to operate said dam and to require and rebuild the same to its present height, and to back and raise the waters of said river and tributaries by said dam along that certain tract of land situate in the County and State aforesaid, and being the lands of the Estate of the said Nathaniel Greene-Rector, lying on said South Tyger River and tributaries. AND we do hereby release the said Apalache Mills, and its successors and assigns from all liability to us, individually and as Executors as aforesaid, and to our successors, administrators, executors, heirs and assigns from all damage, past or future, which has resulted, or may result, to the said lands by the erection and maintenance of the said Dam. Lands lying on South side of South Tyger River, containing six acres, more or less.

AND we, as executors and as individuals, do hereby bind ourselves, our successors, heirs executors, administrators and assigns, to warrant and forever defend all and singular the rights and easements herein granted unto Apalache Mills, its successors and assigns, from and agains us, and our successors, heirs, executors, administrators and assigns, and every person whomsoever lawfully claiming or to claim the same, or any part thereof.
