of said trust property, or both, as circumstances may permit, any just debts which are now or may hereafter be due and owing by me for any reason whatever, including my share (being one-half) of any legal and valid debts incurred in the operation of the Greenville Steam Laundry for which I may be legally liable; and to pay all of such net profits and income not used to me, the said Edith M. Hoke; with full power and authority also in and to the said trustee to pay the whole or any portion of the principal of such trust fund to me, the said Edith M. Hoke, or for my benefit, at any time or times and from time to time, so often as the same may be necessary or advisable in the opinion of such trustee.

- 3. In trust, upon my death, to pay all medical and other expenses of my last illness and funeral, and of a suitable tombstone to me memory; and to re-invest all profits thereafter arising and allow the same to accumulate during the natural lives of my son, David Mills Hoke, and his wife, Grayson M. Hoke, and during the natural life of the survivor of my said son and his wife; with full power and authority, however, in and to the said trustee to apply the whole or any part of the income and the whole or any part of the principal of such trust fund to the support of my said son and his wife and the support and education of their children, or any one or more of them, or to pay out the same for the benefit of my said son and his wife, and of their children, or that of any one or more of them, at any time or times and from time to time, if in the opinion of said trustee it is necessary or advisable so to do.
- 4 . In trust, upon the death of the survivor of my said son and his wife, to re-invest all profits thereafter arising and allow the same to accumulate until their youngest child shall attain the age of twenty-one years; with full power and authority, however in and to the said trustee to apply the whole or any part of the income and the whole or any part of the princidal of such trust fund to the support and education of my grandchildren or of any one or more of them, or to pay out the same for their benefit, or that of any one of more of them, at any time or times and from time to time, if in the opinion of said trustee it is advisable so to do 5. In Trust, when my youngest grandchild shall attain the age of twenty-one years, to reduce to money the whole of the trust property then in the hands of said trustee, including the accumulations, if any, and to distribute and pay over the same, (less the expenses of administering said trust, including the usual trustee's commissions) to and among my said grandchildren who may then be living and the issue, per strepes, of any one or more of my said grandchildren who may have died leaving issue living at the time of his, her or their death in equal shares, freed and discharged of all trusts, so that the children of any one of more of my said crandchildren who may have previously died, leaving issue living at the time of his, her or their death, shall take among them the equal share to which his, her or their parent or parents would have been entitled, if then alive; and in the event that all of my grandchildren shall die before reaching the age of twenty-one years, leaving no issue of any of my said grandchildren living at the time of his, her or their death then ( after the death of my said son and his wife) in trust to pay over the whole fund then remaining in the hands of said trustee to and among such person or persons as may at that time be entitled to inherit my estate under the laws of the State of South Carolina governing the distribution of intestates' estate. And I do hereby covenant and agree to and with the said L.O. Patterson and his successor and successors in the trust that I will from time to time, upon the demend of the trustee hereunder for the time being, execute and deliver whatever other instrument of writing, deeds, conveyances and assurances in the law may be reasonably required for the better assigning, assuring, conveying and confirming unto the said trustee for the time being, for the uses and purposes of this trust, the whole or any part or parts of the property-(next page)
