Quinn all that certain lot, piece or parcel of land situate, lying and being in the State of South Carolina and County of Greenville, in the Second Ward of the City of Greenville, having the following metes and bounds, to wit:
Beginning at a stake on the East side of Main Street, fifty-five feet Northward from the Northwest garner of the lot conveyed by Mrs. Aurolia T. Munn to J.H. Olbert and J.D. Smith

Beginning at a stake on the East side of Main Street, fifty-five feet Northward from the Northwest corner of the lot conveyed by Mrs. Aurelia T. Munn to J.H. O'Neal and J.D. Smith, and running; thence Scuthwardly along the East side of said Main Street fifty-five (55) feet to the corner above mentioned; thence Eastwardly along the North line of the said lot belonging to O'Neal and Smith two hundred and thirty-five (235) feet, more or less, to Brown Street; thence Northwardly along the West side of Brown Street fifty-five (55) feet to a stoke; thence in a straight line two hundred and thirty-five (235) feet, more or less to the beginning corner; this being a portion of the lot of land conveyed to Miss. TOGETHER with all and singular the rights, members, hereditaments and appurtenances to the said premises belonging or in anywise incident or appertaining;

TO HAVE AND TO HOLD all and singular the premises before mentioned unto the said M. Quinn and her heirs and assigns forever.

I do hereby bind myself as Trustee and my successors in the Trust to warrant and forever defend all and singular the said premises unto the said M. Quinn and her heirs and assigns against myself and my successors in the trust and against every person whomsoever lawfully claiming or to claim the same or any part thereof, in so far as I may lawfully warrant the same under the terms of the two trust deeds and decree above referred to.
