One hundred and twenty-six feet and one inch along Boyce Avenue to an iron pin on alley ten feet wide; thence S. 76-45 W. seventy-one feet and eight inches along said alley to iron pin, corner of lot No. 5; thence S. 15 E. one hundred and twenty six feet and one inch along lines of lots P No. 5 and No. 6 to iron pin on Pettigrue Street; thence N. 76.45 E. Seventy-one feet and eight inches along Pettigrue Street to the beginning, known as lot No. 6 of Block No. 4, on plat of Boyce Lawn Addition made by J.T. Lewrence on Jan. 22nd, 1909. X TOGETHER with all and singular the rights, members, hereditaments and appurtenances to the said premises belonging or in anywise incident or appertaining.
