All that lot of land, with the buildings thereon, situate, lying and being on the South side of Main Street, almost opposite Chicora College, in the City of Greenville, State of South-Carolina, having a frontage of forty (40) feet, with a depth of one hundred and fifty (150) feet and more particularly described as follows:

Beginning on Main Street at the corner of D.L. Bremlett's lot; thence Southward with Bramlett's line one hundred and fifty (150) feet; thence Westward along a line parallel with Main Street forty (40) feet, thence Northward along a line parallel with D.L. Bramlett's line One hundred and fifty (150) feet to Main Street; thence Eastward with Main Street forty (40) feet. Butting and bounding North on Main Street, East on lot of D.L.
