Rhodes of R.F.D. # 6, Greenville, Postoffice Greenville County, South Carolina, and National Light and Thorium Company a corporation of Delaware; Titnesseth, that said agreement of February 14th., 1905 is hereby amended as follows; The said Company hereby agrees not to mine for monizite in the bottom lands and hillsides on said land, but only in the beds and runs of the Creek and branches on said land and such small strips of land immediately adjoining same as may be advantageously cut off in Order to straighten the courses of said creek or branches, the said Company Airther agrees that in working tollett's Croek the ditch shall be man on the right hand bank going down said creek and so far as possible the gravel shall be thrown on the left hand side of said Crock.
