Garrison, her heirs, executors and administrators of and from all actions, claims and demands what soever for or by reason of said deficiency in said lot as aforesaid, and in consideration of the premises and the said sum of money paid to me by the said Mart T. Garrison, have granted bargained, sold and released, and by these presents, do grant, bargain, sell and release unto the said Lula B. Bryan, All that certain piece or strip!of land on Rhett Street in the City and County of Greenville, State of South Caroline, and having the following metes and bounds, to wit: Beginning at an iron pin 3X on Rhett Street, ninety-six (96) feet from corner of Markley and the said Rhett Streets, and running; thence with Rhett Street N. 70-2 E. 4 feet to an iron pin, 3X; thence N. 18-2 W. 65 feet to an iron pin, 3X on Mrs. Linsey's line; thence with her line S. 70-2 W. 4 feet to an iron pin 3X; thence S. 18-2 E. 65 feet to the beginning corner, containing two hundred and sixty (260) square feet, more or less, and being a part of the lot of land, conveyed to the said M.P. McHugh by Mary T. Garrison by deed dated December 5th, 1905 and recorded in R.M.C. office for Greenville County in Volume R.R.R., page 272. TOGETHER with all and singular the Rights, Members, Hereditaments and Appurtenances to the said premises belonging or in anywise incident or appertaining. TO HAVE AND TO HOLD all and singular the premises before mentioned unto the said Lula B. Bryan, her, heirs and assigns forever. And I do hereby bind myself, my heirs, executors and administrators to warrant and forever defend all and singular the said premises unto the said Lula B. Bryan, her heirs and assigns against me and my heirs.
