of Greenville County in the State aforesaid, in consideration of the sum of Eleven Hundred fifty and no/100 Dollars to me in hand paid at and before the sealing of these presents by St. St. Prince of the County of Greenville, South Carolina (the receipt whereof is hereby acknowledged), have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto the said St. St. Prince, all that piece of parcel or lot of land situated, lying and being in the Town of Travelers Rest, on Quincey as Main street, in the County of Greenville in the state of South Carolina, being lots No 9 and 10 as represented on plat made by E. M. Hunt Surveyor of the lands of R. W. Anderson; Beginning at a stake on said Quincey road or Main street and running 2 1/2 N. 100 feet to a stake on corner of A. N. Gilreath's Lot formerly owned by R. B. Johnson; thence N. 87 1/2 E. 337 feet to a stake on each side of Branch; thence N 2 1/2 W. 100 feet to a stake on West side of Branch; thence 87 1/2 N. 337 feet to the Beginning corner, containing 3,900 square feet more or less, and being the square lot which was conveyed to me by Naming B. Morgan by deed bearing date Jan. 28<sup>th</sup> 1895 recorded in the R.P.M.C. office at Greenville S.C. in Book A.B.B. page 802.
