(the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said J. B. Brookshire, all that certain piece or parcel of land, lying and being, situated in Chick-Springs Township in the County and State aforesaid, on both sides of the Rutherford Road, and containing twenty-six acres, more or less, and having eight interfard bounds, marks &c as follows: Viz; Beginning at a stake in the said Rutherford Road and running thence S 8 E. 47.60 to a post oak 3x; and thence N. 75 E. 16.65 to Historic stake, F. M. Taylor's Corner; thence N. 15 1/2 E. with Taylor's line 9.12 to a stone in the edge of the Public Road; thence N. 56 E. 9.83 to a stone Taylor's Corner, on the original line; thence N 32 1/2 W. 23.72 to a Black Oak 3x; thence S. 86 1/2 W. 15.33 to a Spanish oak 3x; thence N. 78 1/2 W. 2.18 to the Beginning Corner.
