The waters of said creek are to be used by the grantee for mining purposes only, and in such a menner as to cause no damage to me, my heirs, executors, administrators or assigns. In the event that the bed of the dreek should at any time be mined it is understood and agreed that I shall have one of all Minerals recovered, less the cost of recovery. This deed is made in pursuance of an agreement made by me for the purpose of assisting my two sons, L. C. Ashmore and W. A.
