(1) Beginning at an iron pin one hundred and eight feet and ten inches west of the south-west corner of Elizabeth and Parle Streets, and running thence parallel with said Elizabeth Street S.17 W. two hundred and six and one half feet to an iron pin; thence N.73 W. three hundred and twenty seven feet to an iron pin, corner of lot of Wilkins, Poe & company, thence N.17 E. two hundred and six and one half feet with their line to an iron pin on Earle Street; thence with earle Street S.73 E. three hundred and twenty seven feet to the beginning corner, and knwon as lots hos.  37.38,39.40.41 and 42, on a plat made by J.N.
