Wereas the stockholders of the corporation Markley Hardware and Manufacturing Company, at a special meeting held on the eighth day of March, A.D. 1911, did authorize the officers of the said coporation

to execute this deed; Now, therefore, Know All MEN BY THESE PRESENTS That Markley Hardware and Manufacturing Company, a corporation chartered under the laws of the State of South Carolina, and having its principal place of business at Greenville, in the State of South Carolina, for and in consideration of the sum of One Hundred Thousand (\$100,000.00) dollars, to it in hand duly paid at and before the sealing and delivery of these presents by the grantee hereinafter named, (the receipt whereof is hereby acknowledged) has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto ALESTER G.FURMAN All those certain lots, pieces or parcels of land situate, lying and being in the State of South Carolina, in the City and County of Greenville, to wit: First, that lot beginning at a stake on the west bank of Reedy River, thirty (30) feet above the site of the present dam supplying power for said corporation, and running thence S.30° 30' E. thirty (30) feet to said dam; thence S. 30° 30' E. along the face of the stone wall constituting the west bank of Reedy River five hundred and eight and one half (508½) feet to the line of the north, side of the former Main Street bridge (recently replaced by a concrete bridge); thence along line of such former bridge N.36° 30' E.two hundred and thirty-two (232) feet to a stake at a bend in Main Street; thence with Main Street N.220 45' E.Pifty six (56) feet to a stake on said Street; thence following the line of said Street N.20° 30' E.one hundred and seventy-five (175) feet to a stake on the west side of Main Street and on the South side of a twelveralley; thence N.69° 30' W. with the south side of said alley one hundred and seventy-nine and thres-quarters (179.75) feet to a bend in said alley; thence N.67° 18' W.(stil along the south side of said alley) one hundred and seventy nine and a quarter (179.25) feet to a stake on the east side of Jackson Street and on the south side of said alley; thence N.69° 24' W. fifty (50) feet to a stake on corner of land belonging formerly to Huguenot Mills; thence with said Huguenot Mill line S.38° 15' W.forty -seven (47) feet to a stake on the east bank of Reedy River thence across said river in a straight line to the beginning corner, the above courses and distances being taken from a plat made by J.E. And the said granting corporation does hereby bind itself and its successors to warrant and forever defend all and singular the said premises unto the grantes hereinabove named, and his heirs and assigns, against itself and its successors, and against every person whomsoever lawfully claiming or to claim the same or any part thereof.
