All that certain piece parcel or lot of land situate lying and being in Greenville Township, in Greenville County, South Carolina on the Casley Bridge Road. Beginning at an iron pin on Casley Bridge Road corner of lot No. 9 and running thence S. 32 3/4 W. Seventy (70) feet to an iron pin; thence S. 40 1/2 E. One hundred and Ninety (90) feet to an iron pin; thence N. 32 3/4 E. Seventy (70) feet to an iron pin; thence N. 40 1/2 W. One hundred and Ninety (90) feet to the beginning corner, containing 13,300 square feet more or less, and being lot No. 10 of a sub-division of land conveyed by J. M. Kennerly to Henry K.
