

Fork of Tyger River, Boundaries on all sides on Vacant Land & hath such shape & marks as the above Plat Represents Surveyed the 1<sup>st</sup> of April 1785

State of south Carolina Pursuant to a warrant from John Thomas Esq<sup>r</sup> Commissioner of Locations dated the 15<sup>th</sup> April 1785 I have admeasured and laid out unto James Jordan a tract of three hundred acres of land situate in Ninety six District East of the ancient Boundary, on the branches of Snare River & branches of Ferguson's Creek of Tyger River, bounding S.E. on land laid out to William Reeves, and on all other sides on Vacant Land, and hath such shape and Marks as the above Plat Represents,

Carolina Pursuant to a warrant from John Thomas Commissioner of Locations, dated the 24<sup>th</sup> day of January 1785, I have admeasured and laid out unto Jonathan Neiball a tract of land containing one hundred and Ninety four acres situate in Ninety six District East of the ancient Boundary, on the Middle Fork of Tyger River, Bounding to the S.E. on land laid out to and by the various courses of the said River, Bounding to the N.W. on all other sides on Vacant Land, and hath such shape and Marks as the above Plat Represents
