GARTICLE 4 OF SECTION 2. The President or a majority of the Executive Communities may appoint Attorneys-in-Fact, Resident Vice Presidents and Resident Assistant Secretaires and assign to them such duties as may be advantageous to the Company including the execution and attestation of bonds, undertakings, recognizances, contracts of indemnity, and all other writings obligatory in the nature thereof and other documents on behalf of the Company with power to redelegate such authority. In case of the death, absence or inability to act of the President, the duties and powers of the President shall devolve upon an acting President who shall be a Director and shall be designated by the Executive Committee and act until the next Directors' meeting."
