with interest thereon from *date* at the rate of *seven* per cent. per annum, to be computed and paid *semi-annually* until paid in full; all interest not paid when due to bear interest at same rate as principal; and if any portion of principal or interest be at any time past due and unpaid then the whole amount evidenced by said note to become immediately due, at the option of the holder hereof, who may sue thereon and foreclose this mortgage; said note further providing for an attorney's fee of *ten per cent of the amount*

besides all costs and expenses of collection, to be added to the amount due on said note and to be collectible as a part thereof, if the same be placed in the hands of an attorney for collection, or if said debt, or any part thereof, be collected by an attorney or by legal proceedings of any kind (all of which is secured under this mortgage); as in and by the said note, reference being thereunto had, will more fully appear.

McKee*, at and before the signing of these Presents, the receipt whereof is hereby acknowledged, have granted, bargained, sold and released, and by these Presents do grant, bargain and release unto the said Mortgagee, *Henry P. Heirs and Assigns, forever, all and singular that certain piece, parcel or tract of land situate, lying and being in *Spigda Township, Greenville County, State of South Carolina*

Containing 79 acres, more or less, bounded by lands of *W. J. Dill, A. Justice, Otis Taylor, et al.*, having the following meters and bounds, to-wit:
Beginning at a stone 3m; thence S. 62 1/3 W. 36.33 to stone 3x; thence S. 29 1/3 E. 21.75 to a red oak 3x; thence N. 62 2/3 E. 36.33 to a stone 3x; thence N. 29 2/3 W. 21.75 to the beginning.
