at the rate of *eight* per centum per annum until paid, interest to be computed and paid *semi-* annually

and if unpaid when due to bear interest at same rate as principal until paid, and *I* have further

promised and agreed to pay ten per cent. of the whole amount due for attorney's fees, if said note be collected by an attorney or through legal proceedings of any

kind, reference being hereunto had will more fully appear.

NOW, KNOW ALL MEN, That *Mollie Syracuse*

in consideration of the said debt and sum of money aforesaid, and for the better

securing the payment thereof according to the terms of the said note, and as a consideration of the further sum of Three Dollars to me,

in hand well and truly paid at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, have granted, bargained, sold and

released, and by these presents do grant, bargain, sell and release unto the said *Mrs. Ella K. Hanna*

all that piece, parcel, tract or lot of land situated in *Greenville*

Township, *Greenville* County, State of South Carolina, *just outside the corporate*

limits of the city of *Greenville* on the north side

of *Augusta* street, known as lot No. 59 on a plat

of said property which is recorded in office

of *R. M. C.* for said county in Plat Book *C.* page

*130* and having the following meters and

bounds: Beginning at a stake on the north side

of *Augusta* street at the east side intersection

of *Augusta* street and *Capers* street; running

thence *N. 43-39 E. 246.1* feet to a stake; thence

*S. 16-08 E. 87.3* feet to stake; thence *S. 43-39 W. 200*

feet to stake on *Augusta* street; thence with

said street *N. 46-21 W. 78* feet to the beginning
