I, Habersel B. Springer, of Greenville, S. C.

SEND GREETING:

WHEREAS, I, the said Habersel B. Springer,in and by my certain even date with these presents,
in the full and just sum of Fifteen Thousand Dollars (\$15,000.00)

Dollars, to be paid three months after the date hereof, with interest thereon from the date hereof, at the rate of 8 per cent. per annum, to be computed and paid quarterly until paid in full; all interest not paid when due to be interest at the same rate as principal; and if any portion of principal or interest be at any time past due and unpaid, then the whole amount evidenced by said note, to become immediately due, at the option of the holder hereof, who may sue thereon and foreclose this mortgage; and in case said note, after its maturity, should be placed in the hands of an attorney for suit or collection, or if before its maturity it should be deemed by the holder thereof necessary for the protection of his interests to place, and the holder should place, the said note, or this mortgage in the hands of an attorney for any legal proceeding, then and in either of said cases the mortgagor promises to pay all costs and expenses, including 10 per cent. of the indebtedness as attorney's fees, this to be added to the mortgage indebtedness, and to be secured under this mortgage as a part of said debt.

Springer,at and before the signing of these Presents, the receipt whereof is hereby acknowledged, have granted, bargained, sold and released, and by these Presents do grant, bargain, sell and release unto the said W. L. Miller,

All that certain piece, parcel or lot of land situate, lying and being in the County and State aforesaid, just outside of the City of Greenville, on Ladsen street, known and designated as Lot #21 Block "C", according to plat recorded in the office of Clerk for Greenville County, in Plat Book "6" page 284, and having the following metes and bounds, according to a survey made by R. E. Dalton, Surveyor, commencing at a stone pipe on the street side of Ladsen street, corner of lot no. 20, said pipe being 234 1/2 feet from the back side of Millie Avenue; thence along the west side of Ladsen street 37.35-32' N. 50 feet to a pipe corner of lot 22; thence along line of lot #22, S. 54-28 W. 183 feet to a pipe on the rear line; thence along the rear line S. 36-50 E. 50 feet to a pipe corner of lot 20; thence along line of lot #20, N. 54-28 E. 182 feet to the point of beginning.
