all that certain lot of land situate in the City of Greenville and County  
of Greenville and being a portion of the same lands represented upon the plat of  
Crescent Terrace, also being a portion of the same lands conveyed to Poinsett Realty Company  
by S. K. Trindal by deed dated June 25, 1919, and recorded in the Register of Mesne Conveyance  
office for Greenville County in Book 54, page 61, the said plat of Crescent Terrace being re-  
corded in Plat Book E, page 137, in the office of said Register of Mesne Conveyance of  
Greenville County, the property herein conveyed being more particularly described as follows:

That certain tract of land being made up and composed of eight separate lots shown upon said plat of Crescent Terrace, said lots being numbers 1, 2, 3, 4, 22, 23, 24, and 25, the first four lots mentioned facing Lindal Ave. and the second four lots mentioned facing Crescent Avenue, said plat of land beginning at an iron pipe at the corner of Cagles Street and Crescent Avenue and running thence along Crescent Avenue south 85 degrees 40 minutes west two hundred seventy-eight and seven-tenths (278.7') feet to the corner of Cagle Park Lands; thence along the Cagle Park Lands north 5 degrees 16 minutes west five hundred and thirty-one and 8-14-tenths (531.6') feet to Lindal Avenue; thence along Lindal Ave. north 89 degrees seven minutes east two hundred seventy-four and six-tenths (274.6') feet to an iron pipe on Cagles Street; thence along Cagles Street south 5 degrees 41 minutes east five hundred and eleven (511') feet to the place of beginning. This is the same property heretofore conveyed to Robert L. Wood side by Deed of Pinsett Realty Co. dated July 31, 1919, and recorded in Book 64, page 342, in the R. M. C. office for Greenville County, reference to which deed is hereby expressly made as a part of this description, and this conveyance is subject to the restrictions set out in said deed.

Being the same property this day conveyed to me by the receivers of Peoples State Bank of South Carolina and this Mortgage being given to secure a portion of the purchase price thereof.
