WHEREAS, We, the said Lucy L. Hudson and E. B. Curry

in and by our certain promissory note in writing, of even date with these presents, are well and truly
indebted to AMERICAN BUILDING AND LOAN ASSOCIATION, a corporation, incorporated under the laws of the State of South Carolina, in the full
and just sum of Fifteen Hundred (\$1500.00) Dollars,

to be paid on or before the date when the First Series of the Installment
