forty-two and 50/100 (42.50) acres, more or less, located, lying and being in Highland Township, County of Greenville, State of South Caroline, being bounded on the North by lands of H.A. Forrester; on the East by lands of Tom Stokes; on the south by lands of W.T. Forrester; on the West by lands of Tom Babb, and having such shape, metes, courses and distences as will more fully appear by reference to a plat thereof made by W.P. Morrow, Surveyor on March 27th, 1925, which plat is on file with the Federal Land Bank of Columbia. Foregoing land was conveyed to Luther Miller Forrester by John F.
