SEND GREETING:

WHEREAS, I, the said H. P. Burbage

in and by my certain promissory note in writing, of

even date with these presents, and well and truly indebted to Peoples

National Bank in the full and just sum of one hundred

Dollars, to be paid annually

with interest thereon from date at the rate of 8 per cent. per annum to be

computed and paid annually

until paid in full; all interest not paid when due to bear interest at the same rate as principal; and if any portion of principal or

interest be at any time past due and unpaid, then the whole amount evidenced by said note to become immediately due, at the option of the holder hereof, who

may sue thereon and foreclose this mortgage, said note further providing for an attorney's fee of ten per cent

besides all costs and expenses of collection, to be added to

the amount due on said note, to be collectible as a part thereof, if the same be placed in the hands of an attorney for collection, or if said debt, or any part thereof, be collected by an attorney or by legal proceedings of any kind (all of which is secured under this mortgage): as in and by the said note, reference being thereunto had, as will more fully appear.

NOW, KNOW ALL MEN, That I, the said H. P. Burbage

in consideration of the said debt and sum of money aforesaid, and for the better securing the payment thereof to the said Peoples National

Bank Executor of the Estate of D. D. Dauverport

according to the terms of the said note, and also in consideration of the further sum of Three Dollars, to me, the said

H. P. Burbage

in hand well and truly paid by the said Peoples National Bank as

Executors of the Estate of D. D. Dauverport

at and before the signing of these Presents, the receipt whereof is hereby acknowledged, have granted, bargained, sold and released, and by these Presents do

grant, bargain, sell and release unto the said Peoples National Bank as Executors of the

Estate of D. D. Dauverport, all that piece parcel or lot of land situate lying and being in the third Ward of the City of Greenville, State and County aforesaid, having the following lines and bounds, to-wit: Beginning at a stake on Richardson Street at the corner of P. P. Hillhouse's lot and running in an easterly direction one hundred feet to a stake; thence in a southwesterly direction fifty three feet to a stake; thence in a westerly direction one hundred feet to a stake on Richardson Street thence with Richardson Street fifty-three feet to the beginning corner. Being the same lot of land conveyed to me by Fannie McHugh see R. M. C. Book 63 page 425.
