and when paid in full, all interest not paid when due to bear interest at the same rate as principal; and if any portion of principal or
interest be at any time past due and unpaid then the whole amount evidenced by said note to become immediately due, at the option of the holder hereof, who
may sue thereon and foreclose this mortgage, said note further providing for an attorney's fee of ten per cent of the amount
due as attorney's fee besides all costs and expenses of collection, to be added to
the amount due on said note, to be collectible as a part thereof, if the same be placed in the hands of an attorney for collection, or if said debt, or any part

corner; thence with Janie Austin's line S. 63° 4' E. 30.77 to the
beginning corner and containing 16-95/100 acres more or less.
Said lot of land being lot no. 2 as shown by plat of survey
made by W. J. Riddle March 28th 1922, in the subdivision of a
tract of land which was conveyed by Caroline Sales to Emory
Sales, Joseph Sales, Samuel Sales and Janie Austin by deed
