SEND GREETING:

with interest thereon from date at the rate of eight per cent. per annum to be
computed and paid Quarterly
until paid in full; all interest not paid when due to bear interest at the same rate as principal; and if any portion of principal or
interest be at any time past due and unpaid, then the whole amount evidenced by said note to become immediately due, at the option of the holder hereof, who
may sue thereon and foreclose this mortgage, said note further providing for an attorney's fee of

Ten Percent (10%) besides all costs and expenses of collection, to be added to
the amount due on said note, to be collectible as a part thereof if the same be placed in the hands of an attorney for collection, or if said debt, or any part
thereof, be collected by an attorney or by legal proceedings of any kind (all of which are secured under this mortgage): as in and by the said note, reference
being thereunto had, as will more fully appear.

grant, bargain, sell and release unto the said Wilton H. Earle, his heirs and assigns

All that certain piece parcel or lot of land situate lying and
being in the State and County aforesaid in the City
of Greenville in Ward Five on Perry Avenue and having the
following metes and bounds, to-wit:

Beginning at a stake corner of Eskew's lot on Perry
Avenue and running thence N. 18° 1/4 E. 200 feet to a stake on
the old Ware line; thence with the Ware line N. 19° 1/2 W. 65
feet to stake on said old Ware line; thence N. 71° 1/4 W.
57 feet to an iron pin; thence S. 18° 1/4 W. 254 feet to Perry
Avenue; thence along Perry Avenue S. 71° 1/4 E. 97 feet to the
beginning corner and containing one-half of one acre, more
