AN that Piece, Parcel or lot of land situate, lying and being in Ward Two of the City of Greenville, County of Greenville and State of South Carolina, on the northeast corner of the intersection of Poinsette Avenue and Bennett Street, and having the following metes and bounds according to a plat thereof prepared by C.I. Furman, Jr., Engineer, on August 14, 1923, to-wit:
