to be paid on or before the date when the 8th. Series of the Instalment

Wallace in consideration of the said debt and sum of money aforesaid, and for the better securing the payment thereof to the said AMERICAN BUILDING AND LOAN ASSOCIATION, according to the terms of the said note, and also in consideration of the further sum of Three Dollars, to me the said H.O. Wallace

in hand well and truly paid by the said AMERICAN BUILDING AND LOAN ASSOCIATION at and before the signing of these Presents, the receipt whereof is hereby acknowledged, have granted, bargained, sold and released, and by these Presents do grant, bargain, sell and release unto the said AMERICAN BUILDING

AND LOAN ASSOCIATION All that piece, parcel or lot of land in Greenville Township,

Greenville County, State of South Carolina, in the City of Greenville, in the Second Ward of said City, and known as Lot #1 of Block 4, of Boyce's Addition, according to a plat recorded in Plat Book "A", at page 179 and having the following metes and bounds to-wit: Beginning at an iron pin on the North-East corner of Pettigru and Toy Streets and running thence N. 15 W. 126 feet and 1 inch along Toy Street to an iron pin on a 10 foot alley; thence N. 76-45 E. 66 feet and 8 inches along said alley to iron pin, corner lot #2; thence S. 15 E. 126 feet and 1 inch along line of lot #2 to iron pin on Pettigru Street; thence S. 76-45 W. 66 feet and 8 inches along said lot to the beginning corner.
