All that certain piece parcel or lot of land with the buildings
and improvements thereon, situated lying and being in the
state of South Carolina aforesaid, in Greenville Township and
having an area of ~~about~~ *48* in ~~square~~ *feet*, as shown on a plat
recorded in plat book *10*, at page *377* and having the
following corners and boundaries, to-wit: Beginning at an
iron pin on Gridley Street and running thence N. *89 1/2* W.
154 feet to iron pin; thence *12 1/2* W. *50* feet to a stake
thence *89 1/2* S. *12 1/2* feet to iron pin; thence *S. 57 1/2 E. 40*
