with interest thereon from date at the rate of per cent. per annum to be computed and paid interest per cent.

until paid in full; all interest not paid when due to bear interest at the same rate as principal, and if any portion of principal or interest be at any time past due and unpaid; then the whole amount evidenced by said note to become immediately due, at the option of the holder hereof, who may sue thereon and foreclose this mortgage, said note further providing for an attorney's fee of per cent. of the amount due besides all costs and expenses of collection, to be added to the amount due on said note, to be collectible as a part thereof, if the same be placed in the hands of an attorney for collection, or if said debt, or any part thereof, be collected by an attorney or by legal proceedings of any kind (all of which is secured under this mortgage): as in and by the said note, reference being thereunto had, as will more fully appear.

at and before the signing of these Presents, the receipt whereof is hereby acknowledged, have granted, bargained, sold and released, and by these Presents do grant, bargain, sell and release unto the said Laura A. Griffin,

All that certain lot of land, situate, lying and being just outside the corporate limits of the City of Greenville in the state of South Carolina, County of Greenville and having the following metes and bounds;

Beginning at a stone at the south-eastern end of an unmarked street sometimes called Hill Street Avenue running along what is known as Birnie's line about 37.8 W. one hundred and seventy-five feet, more or less, to a stone, thence about N. 49° W. twenty feet to a stake; thence in a south-westerly direction one hundred and twenty-eight feet to a point on the said Hill Street Avenue, one hundred and two feet from the beginning corner thence along said line Avenue one hundred and twenty-two feet to the beginning corner, being the upper portion of that certain lot conveyed to the Grantee by E. B. Lewis by deed dated January 1894 and recorded in the R. M. C. office for Greenville County in Deed Book A. B. A. page 348, and this day added to the grants so herein by Laura A. Griffin,
