Dollars, to be paid *as follows: to-wit: Five hundred and no/100 dollars,*
on the 1st day of February A.D. 1924, Five hundred and
no/100 dollars on the 1st day of February A.D. 1925, and the
remaining One Thousand and no/100 dollars on the 1st day
of February A.D. 1926. date. at the rate of *8* per cent. per annum to be

computed and paid *semi-annually*
until paid in full; all interest not paid when due or interest at the same rate as principal; and if any portion of principal or
interest be at any time past due and unpaid, then the whole amount *of said note* shall be immediately due, at the option of the holder hereof, who
may sue thereon and foreclose this mortgage, said note further providing for an attorney's fee of *\$1.00*

grant, bargain, sell and release unto the said *J. M. Andrea, his heirs and assigns*

forever: All that certain piece, parcel or lot of land
situated, lying and being in Greenville Township
County and state aforesaid, near the corporate limits
of the City of Greenville in section known as Cherokee
Park, and being known and designated as lot #
56 as shown on plat of said Cherokee Park recorded
in the R. M. C. office for Greenville County in Plat
Book "C" at page 96, and having the following
metes and bounds, to-wit:

Beginning at the corner of Grove Road and
Saluda street and running thence with Saluda
street S. 62.32 E. 172 feet to an alley; Thence along
said alley N. 27.28 E. 50 feet to a stake; Thence N. 82.32
